RRECS 4241-A PRINTING AND DISTRIBUTION

The PS Form 4241-A, Rural Route Evaluation, contains a summary of the data utilized to determine a route evaluation.

On Saturday, April 1, 2023 the PS Form 4241-A will be available and must be printed in RMSS.

Print all 3 pages of PS Form 4241-A for each route in unit

- Assigned Carrier copy for the route
- Route Book copy filed at the carrier case
- Route Folder copy (maintained by management in the local office)

The PS Form 4241-A must be provided to the carrier in order to communicate the new RRECS evaluation for the route.

Ensure the carrier is immediately made aware of schedule changes

• Classifications: K, J, or H

In addition to the PS Form 4241-A, you must also provide carrier a copy of the 4241-A RRECS Cheatsheet

If carrier request copy of their 4241-M, you must provide a copy which can also be found in RMSS
